

CORRIGENDUM TO THE NOTICE OF THE EXTRAORDINARY GENERAL MEETING

Banka BioLoo Limited (“Company”) had issued a notice dated 19.02.2022 for convening an Extra-Ordinary General Meeting of the members of the Company (EGM Notice) on Sunday, 20 March 2022 at 4 PM (16:00 Hours), at its corporate office at 5th floor, Prestige Phoenix, 1405, Uma Nagar, Begumpet, Hyderabad – 500016, through video conferencing (“VC”)/other audio-visual means (“OAVM”). The Notice of the EGM was dispatched to the shareholders of the Company in due compliance with the provisions of the Companies Act, 2013, and rules made thereunder, read with circulars issued by Ministry of Corporate Affairs and Securities Exchange Board of India.

- a) There was a typographical error in the EGM Notice on the first page, wherein the date of the EGM was mentioned as 20.03.2021, instead of 20.03.2022. Kindly note that it should be read as 20.03.2022.
- b) In Explanatory Statement, page number 18 of EGM Notice, in Point 6 it was mentioned as “**Not Applicable**”. Pursuant to provisions of SEBI ICDR Regulations, 2018, members are requested take note and read the following against aforesaid Point number 6 instead of “Not Applicable”.

“There is no such proposal of the promoters, directors or key management persons of the Company to subscribe to the proposed preferential issue.”

- c) In Explanatory Statement on page 22 of EGM Notice, in Shareholding Pattern (SHP), Acsys Investments Pvt Ltd, one of the proposed allottees, was mentioned under Individual Category, which should be under Bodies Corporate Category. Hence, in the said SHP **in Point B2 of the shareholding pattern of Other Individuals and Bodies Corporate shall be read as follows:**
